The Maghreb Economic Forum (MEF) is an independent Think-and-Do Tank founded in 2011 on the premise of supporting economic and social development in the Maghreb region.

MEF's mission has always been to convene and mobilize diverse actors to catalyze sustainable economic and social development in the Maghreb.

In this endeavor, MEF operates by :

- Conducting research and publishing policy analysis on contemporary issues in the Maghreb. MEF masters the different instruments of scientific analysis, the concern for accuracy in grasping the complexity of the national and regional situations, and the capacity to exchange and dialogue in mutual respect with the supporters of different perspectives.
- Mobilizing knowledge and ideas to influence the policymaking process.
- Fostering dialogue among key community stakeholders.
- Contributing to the emergence of an enlightened, informed, and involved Tunisian civil society in order to preserve the democratic conditions for the management of public policies.
- Encouraging the active participation of civil society and decision-makers in the development of public policies and in their governance.
- Promoting and facilitating political dialogue and the exchange of good practices between public and private actors on issues of democracy, security, education, and culture in order to promote political dialogue. Dialogue and education are at the heart of our mission.
- Reinventing the role of think tanks: this means moving out of the self-referential bubbles, engaging critically with power, and rethinking responsibilities toward society at large. This does not divert from the original mission of think tanks to provide research on policy issues for government and centers of decision-making but it would help give them contemporary relevance, integrity, quality, and autonomy from power.

In a few years, the MEF has become an actor uniting around it a rich and varied ecosystem (institutions, universities, colleges, public and private companies, and media). The governance of the MEF is organized around an office, an orientation council, and a board of directors made up of personalities who are leaders in their field. The MEF is a non-partisan, financially independent organization and declares no conflict of interest.

The ability of the MEF to create links at different levels was highlighted: a link within civil society through the facilitation of strategic debate and educational work; a link between citizens and decision-makers when it comes to alerting the authorities on certain issues; finally, between decision-makers, thanks to the organization of formal or informal meetings, allowing reflection and high-level exchanges. We have always been reminded of our essential advisory role, to provide players with original insight, in-depth reflection, and the hindsight essential for decision-making.

### **LEGACY INTERNATIONAL**

The Professional Fellows Program (PFP) for economic empowerment in the Middle East and North Africa is a two-way exchange program sponsored by the U.S. Department of State and designed to promote mutual understanding, enhance leadership and professional skills, and build lasting, sustainable partnerships between mid-level emerging leaders committed to strengthening their communities through social entrepreneurship and workforce development.

The Maghreb Economic Forum was responsible for arranging the following:

- Coordinate with the Fellows to arrange professional virtual consultations and webinars in the workplaces of the Fellows who traveled to the US.
- Coordinate with the Fellows to arrange cultural exchange activities online between the US delegation and participants to give a sense of the history and culture of the region.
- Recruit participants (in consultation with Fellows) for webinars via social media and other advertising methods.
- Provide meeting space and connectivity (as needed) to Fellows and participants to attend virtual sessions.
- Provide translation services as needed (if the audience does not speak sufficient English).

The program took place in Virginia and Washington D.C. with Fellowship placements in either Austin Texas or Washington DC.

This project aims at providing the civil society in Gafsa and Tataouine with the capacity to advocate for better natural resource governance. It revolves around understanding the situation of national resource governance including revenue-sharing mechanisms, corporate social responsibility, and access to available open data. it also includes modules on the decentralization process in Tunisia, including legal responsibilities of local institutions, challenges, and opportunities for local civil society, as well as policy analysis and evaluation techniques, focusing on policy briefs and advocacy tools.





## TTCSP | DERASAT BAHRAIN

The Bahrain Center for Strategic, International & Energy Studies (Derasat) and Think Tanks and Civil Societies Program (TTCSP) of the Lauder Institute at the University of Pennsylvania hosted the 2021 Global Think Tank Summit under the theme "Global Trends and Transitions in Think Tanks, Politics and Policy Advice in the Age of Policy Dilemmas and Disruptions". The summit was held December 5th – 7th, 2021 in the Kingdom of Bahrain. The most influential and innovative think tanks from around the world gathered to discuss the responsibilities and capacities of think tanks and research institutes in light of global crises, such as the Covid-19 pandemic, as well as the challenges and opportunities to support stability and recovery.

## TRANSFORMING AND BUILDING RESILIENT ECONOMIES IN AFRICA.



## **ACET FOR AFRICA**

The Government of Japan and the Japan International Cooperation Agency (JICA) have been supporting Africa's transformative efforts since Ticad3 in 2003 when the New Economic Partnership for Africa's Development (NEPAD) was agreed upon as the main theme of Africa's development. More specifically, JICA has been taking the lead in initiatives such as: doubling rice production, corridor development, One-Stop Border Posts (OSBP) since the 2000s, and more recently, promoting Japanese business in Africa, digital innovation, start-ups, etc.

While the global COVID-19 pandemic is a crisis it can also offer the opportunity for Africa to "build back better" in the post-COVID-19 era. In this context, ACET (African Center for Economic Transformation) received from JICA the task to carry out policy-oriented research on "New African Policy Agenda" to be discussed with the government of African countries and their development partners.

The Japan International Cooperation Agency (JICA) facilitated this study as part of a broad research process to support the formulation of a new policy agenda to help Africa realize strong growth recovery while building resilient economies in the post-COVID-19 era. The final report was prepared for discussion at the Eighth Tokyo International Conference on African Development (TICAD8) that was held in August 2022 in Tunis, Tunisia.

The Maghreb Economic Forum had the privilege to be assigned to conduct Tunisia's study with consultancy services performed by Prof. Aram Belhadj.

Along with Tunisia, five other country case studies were conducted by policy analysis research institutions and teams of private consultants. They include Ghana, Kenya, Mozambique, Rwanda, and Zambia.



# PROMOTING ACCOUNTABILITY IN SOCIO-ECONOMIC POLICIES IN TATAOUINE.

## NATIONAL ENDOWMENT FOR DEMOCRACY

MEF held a 4-day workshop for many civil society activists in Tataouine, drawn from a range of groups active in socioeconomic advocacy, that aims to enhance their understanding of the context of the socioeconomic conflicts in Tataouine and the various stakeholders and circumstances. The workshop included sessions on:

- O1. The history of oil and gas production in the region.
- O2. The conflict in 2017 : Background and stakeholders.
- O3. The 1st agreement reached between protestors and the government in 2017.
- O4. An analysis of the reasons for the failure of the first agreement.
- O5. The second agreement of 2020.
- 06. Session on access to open data.
- 07. Data collection methodology.

## CROSS-COUNTRY POLICY LEARNING EVENT



## **ACET FOR AFRICA**

On behalf of Japan International Cooperation Agency (JICA), the African Center for Economic Transformation (ACET) carried out a policy-oriented research on a New Policy Agenda for Africa (NPA) as part of the process of learning lessons from continental development experiences and as a key input to the 8th Tokyo International Conference on African Development (TICAD8) in August 2022. As part of this work, ACET organized case studies in Ghana, Kenya, Mozambique, Rwanda, Tunisia, and Zambia. This research has produced country-specific and cross-country findings and policy recommendations to help African countries transform while building resilient economies in the post-COVID-19 era. These recommendations were discussed at TICAD8, co-organized by the Government of Japan (GOJ), the African Union Commission (AUC), the United Nations Office of the Special Adviser on Africa (UNOSAA), the United Nations Development Programme (UNDP), the World Bank (WB), and African governments. This cross-country policy learning event convened government policy makers, experts, representatives from the business community and civil society, and development partners from the six countries covered in the report to exchange views and draw lessons to enhance economic transformation and build resilience, centered around the findings of ACET's and partners' research. The discussions during this event provided an opportunity for collective learning, and improve the NPA report.

### NATIONAL ENDOWMENT FOR DEMOCRACY

The Maghreb Economic Forum has launched with the participation of the civil society in Tataouine "Bounoud.tn" Platform. "Bounoud.tn" is a fully integrated, centralized, reliable, and comprehensive online database that maps, analyzes, and assesses the conflict between protesters and the government, and the agreements and promises made by the government related to socio-economic development in Tataouine.

This platform is meant to be an overarching framework aiming to help the various actors involved in this agreement track progress toward its implementation and contribute to creating a context built around transparency and mutual trust.

The Agreement's promises are subdivided into 6 main sections touching upon the environment, plantation, and gardening Company, the investment and development fund of Tataouine, the South Services Company, the employment in oil companies and companies operating in the desert, the stalling projects in Tataouine and finally the settlement of the consequences of El-Kamour movement and its outcomes.

The two other sections investigate the mechanisms of executing this agreement and the method of executing it.

# TACKLING YOUTH RADICALIZATION IN POST-REVOLUTIONARY TUNISIA THROUGH INCLUSION.

## INTERNATIONAL DEVELOPMENT RESEARCH CENTRE: IDRC

The project undertaken by MEF with support of IDRC is an attempt to gain a better understanding of key factors that drive youth impetus to join violent extremist groups. It is based on direct interaction with a group of Tunisian youth using interviews and focus groups and examines whether radicalized youth have financial difficulties (unemployment, economic exclusion), issues of social support and social recognition (identity crisis, ocial exclusion), or are culturally marginalized (cultural exclusion).

This document comes to provide the keys to understanding and exploring the radicalization phenomenon which plagues our countries. Intensified by the notion of global village, the loss of identity, the repeated economic crises and their corollary unemployment, the galloping world demography, the clash of civilizations but also that of religions, the growing inequalities, this radicalization finds its source both within our countries and internationally. So many elements that contribute to identity withdrawal and very probably to the rise of violent extremism.
